



JACKED VENT™ LIMITED WARRANTY

Your vent is covered by a limited warranty for a period of 4 years which begins on the date of purchase. During that time, for any vent that does not perform properly as a result of a manufacturing defect, as determined by Golden Rule Fasteners (hereafter sometimes referred to as GRF), GRF will provide you with replacement part(s) or a replacement vent. Decisions as to the provision of replacement part(s) or a replacement vent will be made solely by GRF. The remedy under this limited warranty is available only for those vents exhibiting defects at the time your claim is evaluated by GRF. Any replacement part(s) or vents, as well as any remaining vents on your roof, will be warranted only for the remainder of the original warranty term. All warranty coverage is subject to the exclusions set forth in the section entitled "Coverage Limitations".

Coverage Limitations

GRF shall not be liable for, and this warranty does not apply to: any failure, defect or damage resulting from or connected with neglect, abuse, misuse or improper handling, or installation not in strict adherence to GRF's written instructions; fire, flood, hail, earthquake, hurricane, lightning, tornado, other violent storms, other acts of God, or impact of foreign objects; damage resulting from the application/installation of adjacent roofing materials or defects in failure of or damage caused by materials used as roofing base over which the product is installed or by movement, distortion, cracking or settling of walls or the foundation of the building; damage resulting from mold growth or condensation; chipping fading, or peeling paint on your vent; or labor costs for removing, repairing, or replacing your vent or any other roofing or building materials.

GRF reserves the right to discontinue or modify any of its products, including color, and shall not be liable as a result of such discontinuation or modification, nor shall GRF be liable in the event replacement material may vary in color in comparison to the original product as a result of normal weathering. If GRF replaces any product under this warranty, it may substitute products designated by GRF to be of comparable quality price range in the event the product initially installed has been discontinued or modified.

Transferability

GRF warrants to the original purchaser or first subsequent owner of the property that the product is free from manufacturing defects for 4 years from the date of purchase. The warranty may be transferred by the original purchaser of the product to the new owner (first subsequent owner) under the terms, conditions, and limitations of this warranty. Under no circumstances shall this warranty extend beyond the original warranty term from the date of original purchase.

How To File a Claim

To file a claim under this limited warranty, you must send a notice of claim describing your complaint, together with proof of purchase to establish that you are the original or second owner and photographs of the affected products (if possible). Box 781178, Tallahassee, AL 36078 within 30 days after your discovery of a potential manufacturing defect. Notice to your contractor or dealer is NOT notice to GRF.

THIS LIMITED WARRANTY IS YOUR EXCLUSIVE WARRANTY FROM GRF AND REPRESENTS THE SOLE REMEDY AVAILABLE FROM GRF TO ANY OWNER OF A GRF Jacked Vent™ VENTILATION PRODUCT. GRF MAKES NO OTHER REPRESENTATIONS, CONDITIONS, GUARANTEES, OR WARRANTIES OF ANY KIND OTHER THAN THAT STATED HEREIN. GRF WILL NOT BE LIABLE IN ANY EVENT FOR CONSEQUENTIAL, PUNITIVE, SPECIAL, INCIDENTAL, OR SIMILAR DAMAGES OF ANY KIND, INCLUDING DAMAGE TO THE INTERIOR OR EXTERIOR OF ANY BUILDING, WHETHER ANY CLAIM AGAINST IT IS BASED UPON BREACH OF THIS LIMITED WARRANTY, NEGLIGENCE, STRICT LIABILITY IN TORT, OR FOR ANY OTHER CAUSE.
